AFFIDAVIT INSTRUCTIONS FOR USE WITH UNDERWRITTEN TITLE COMPANIES

As part of the application process, the underwritten title company must ensure completion of both the <u>Organizational Affidavit</u> and the <u>Individual Affidavit(s)</u>.

The <u>Organizational Affidavit</u> (Part I) must be completed and verified by an executive officer of the organization. Attached is a sample verification form. Please see below for further instructions:

- a) In the case of an application for an <u>organizational securities permit</u>, the Organizational Affidavit must be completed and verified by an executive officer of the underwritten title company.
 - i) Where the ultimate controlling parent is not an individual, the controlling parent organization must submit an Organizational Affidavit, completed and verified by an executive officer of its organization.
- b) In the case of an application for a <u>reissued underwritten title company license</u>, the Organizational Affidavit must be completed and verified by an executive officer of the underwritten title company.
- c) In the case of an application for the <u>transfer of shares</u>, an Organizational Affidavit must be completed and verified by an executive officer of:
 - i) Each non-individual transferee.
 - ii) All entities that own 10% or more interest in the non-individual transferee.
 - iii) All entities that will own 10% or more of the underwritten title company's ultimate controlling parent as a result of the transfer of shares.

The Individual Affidavit (Part II) must be completed by all of the following individuals.

- a) In the case of an application for an organizational securities permit:
 - i) The underwritten title company's officers, directors & key management personnel for each county in which the company intends to transact business.
 - ii) Individuals who will have 10% or more beneficial ownership of the underwritten title company [direct or indirect including attribution].
 - iii) Individuals who own 10% or more of the underwritten title company's ultimate controlling parent.
- b) In the case of an application for a <u>reissued underwritten title company license</u> (adding new counties):
 - i) Each new officer and director appointed to the underwritten title company.
 - ii) Key management personnel for the additional counties into which the underwritten title company intends to expand.
 - iii) Individuals who will have 10% or more beneficial ownership of the underwritten title

company [direct or indirect including attribution] as a result of this expansion.

- iv) Individuals who will own 10% or more of the underwritten title company's ultimate controlling parent as a result of this expansion.
- c) In the case of an application for the <u>transfer of shares of an underwritten title company</u>:
 - i) Individuals who will own 10% or more of the underwritten title company as a result of this transaction.
 - ii) Individuals who own 10% or more interest in the non-individual transferee.
 - iii) Individuals who will own 10% or more of the underwritten title company's ultimate controlling parent as a result of this transaction.

The responses to the affidavits <u>must</u> be typed and <u>all</u> questions <u>must</u> be answered. Do not leave a space blank. If additional space is required, attach an addendum numbering the response to the corresponding question. <u>Submit the original affidavit(s) plus 2 copies.</u>

- 4. County Manager
- 5. Title Plant Manager
