California Identification (California ID)

California Resident Applicants - The California Department of Insurance's (CDI) online license application service requires that you enter your California Identification number (California ID) that was provided to you when you passed your qualifying license examination. The California ID is a 12 digit number that is located on the upper left corner of your passed examination letter. If you are unable to locate your California ID, please review the <u>sample letter</u> that shows you the location of the California ID on your passed examination letter. The change affects California residents applying for any license in which an examination is required (i.e., life, accident and health, property, casualty, personal lines, limited lines automobile, and life limited to funeral and burial expenses).

Please insert your California ID that is listed on your passed examination letter in the space listed below:

The online application service will only allow the application to be submitted if the individual enters the correct identification number and has <u>passed</u> the examination. Therefore, it is imperative that your California ID is identical to what is stated on your passed examination letter.
