firmly bound unto the People of the State of California in the penal sum of TWO THOUSAND	
(\$2,000) DOLLARS to be paid to the said State of California, for which payment, well and truly	
to be made, we bind ourselves, our heirs, executors, successors and assigns, jointly and severally	,
firmly by these presents.	
The conditions of this obligation are such, that:-	
WHEREAS, the said Principal is about to apply or has applied to the Insurance

his activities as a life insurance analyst and also shall be conditioned upon the faithful accounting	
and application of all moneys coming into said Principal's possession in connection with his	
activities as a life insurance analyst;	
NOW, THEREFORE, if said Principal shall not damage any person by fraudulent act or	
conduct in connection with said Principal's activities as a life insurance analyst and shall	
faithfully account for and apply all moneys coming into his possession in connection with his	
activities as a life insurance analyst, then this obligation shall be void; otherwise to remain in ful	1
force and effect.	
The total aggregate liability under this bond is limited to the sum of \$2,000.	
This bond shall take effect on 19 but not prior to the date of its
