

**California Department of Insurance**  
**Fiscal Year 2012-13 Informational Report on Intervenor Program Costs**

California Insurance Code Section 1861.10 provides for consumer participation in Department proceedings conducted pursuant to Proposition 103. These consumer representatives (intervenor) are entitled to compensation for their reasonable advocacy fees and the expenses they incur in proceedings conducted by the Department.

Intervenor generally participate in two types of proceedings – rulemaking and prior approval rate hearings. The rulemaking matters relate to the promulgation of regulations intended to implement provisions of Proposition 103. The prior approval rate hearings concern rate applications by specific insurance companies.
