On November 2, 2022, Applicant ceased writing all new homeowners business in 4 California but did not file updated underwriting guidelines reflecting this change. 5 As a result of the discussions and negotiations between Applicant and the F. 6 Department, Applicant has updated the Application including without limitation by publicly filing 7 updated underwriting guidelines. 8 9 **STIPULATION** 1. This Stipulation, together with the updated Application and the Commissioner's 10 approval in SERFF, represents the complete and final settlement resolving all issues between the 11 12 Department and Applicant regarding the Application. 2. Based upon the Application and additional information which Applicant provided, 13 Applicant and the Department agree that an overall rate change of +4.0% is supportable and 14 should be implemented in accordance with this Stipulation, the updated Application, and the 15 Commissioner's approval in SERFF. Applicant has made appropriate updated filings in SERFF 16 to reflect the overall rate change. Approval of the Application described in this Stipulation will 17 only be effective when approved by the Commissioner in SERFF. Applicant will implement the 18 19 rate change with an effective date of June 27, 2023. 3. Applicant agrees that the approximately 39,000 policies it issued in the 1,047 zip 20 codes it added to its New Business Eligible Zip Codes during the period from February 2021 to the 21 date of execution of this Stipulation will remain in force as long as they otherwise continue to meet 22 23 Applicant's renewal guidelines. Should Applicant, in the future, initiate a nonrenewal program 24 affecting these 39,000 policies or any other policies, make any other changes to its New Business Eligible Zip Codes, or make any changes to its renewal business eligibility guidelines, it agrees to 25 inform and publicly file with the Department any such proposed changes to its underwriting 26 guidelines prior to implementing any such changes. Regarding the public filing of underwriting 27 guidelines filed with rate applications, Applicant will adhere to the August 10, 2018, 28

1	General Counsel opinion letter and Applicant will comply with applicable laws, regulations, and		
2	rate filing instructions as they relate to underwriting guidelines. Additionally, Applicant shall		
3	submit to the Department a completed application for all changes to existing rating and		
4	underwriting rules before implementing any such changes. If the changes described above do not		
5	impact filed rates, they must still be publicly filed before implementation, but they are not subject		
6	to prior approval.		
7	4. This Stipulation does not constitute an endorsement or approval of models		
8	generally, or any specific model, eligibility or nonrenewal criteria, or rating methodology.		

9 5. This Stipulation is made solely to reach a compromise between Applicant and the Department. Pursuant to 10 CCR section 2656.4, discussions, admissions, concessions or 10 offers to stipulate or settle made by any party in negotiating this stipulated settlement, are 11 12 confidential and are not discoverable or admissible for any purpose in any proceeding, except to the extent permitted by 10 CCR section 2662.3(b)(3), and the Commissioner's approval of the 13 Application shall not constitute approval of or precedent regarding any principle or any issue in 14 any other proceeding. 15

6. The Commissioner retains jurisdiction to ensure that Applicant and the 16 Department comply with this Stipulation and the updated Application and the Commissioner's 17 approval in SERFF. 18
