Commissioner Jones appoints new Insurance Diversity Task Force

Industry representatives, diverse business suppliers and insurance experts come together to increase diversity in the industry

SACRAMENTO, **Calif.** – Insurance Commissioner Dave Jones today announced the members of the 2015-2016 Insurance Diversity Task Force, which will make recommendations to the commissioner regarding ways to increase diversity in procurement and governing boards within the insurance industry.

"I am honored to announce the members of the new Task Force, who all share the common goal to create greater diversity in the insurance industry," said Commissioner Jones. "Insurance is a \$257 billion a year industry in California and I remain committed to making sure our state's diverse business owners have the opportunity to benefit from this industry, which so greatly impacts our economy. I am confident the wide array of expertise our new Task Force members bring will benefit our work in meeting these goals."

Task Force members will identify actions the commissioner and the department can take to encourage insurance companies to utilize diverse suppliers and to increase diversity amongst their governing boards. They will also make recommendations for changes to the law and collaborate and partner with state and national leaders on diversity issues.

Since 2011, the Department of Insurance has conducted surveys of the nation's top insurers to understand whether they are purchasing goods and services from the state's minority-, women-, disabled veteran-, and LGBT-owned businesses. Last year the department also conducted a first-in-the-nation survey of the state of diversity across insurer governing boards. The results reveal approximately 80 percent of insurer board members are men, and nearly 83 percent of board members are Caucasian.

The first Task Force meeting will be held on Monday, March 23, 2015.
