***FELONY COMPLAINT  
FOR ARREST WARRANT***

The undersigned is informed and believes that:

**COUNT 1**

On or about March 6, 2015, in the County of Los Angeles, the crime of THEFT FROM ELDER OR DEPENDENT ADULT, in violation of PENAL CODE SECTION 368(d), a Felony, was committed by CLEMENT IGNATIUS LANCELOT CHICHESTER and BRITTNEY JADE SIAS, who did unlawfully commit theft, embezzlement, forgery, fraud, and identity theft with respect to the property and personal identifying information of an elder and dependent adult, said property, moneys, labor, goods, and services taken and obtained having a value exceeding \$950.00, and knew and reasonably should have known that said person, LORRAINE SECOR, was an elder and dependent adult.

COUNT 2

On or about March 6, 2015, in the County of Los Angeles, the crime of PROCURING AND OFFERING FALSE OR FORGED INSTRUMENT, in violation of PENAL CODE SECTION 115(a), a Felony, was committed by CLEMENT IGNATIUS LANCELOT CHICHESTER and BRITTNEY JADE SIAS, who did unlawfully and knowingly procure and offer a false and forged instrument to be filed, registered, and recorded in a public office within this state, which instrument, if genuine, might be filed, registered, and recorded under a law of this state or the United States.

COUNT 3

On or about March 6, 2015, in the County of Los Angeles, the crime of FORGERY NOT RELATING TO A CHECK, BOND, BANK BILL, NOTE OR MONEY ORDER, in violation of PENAL CODE SECTIONS 470(d) and 473(a), a Felony, was committed by CLEMENT IGNATIUS LANCELOT CHICHESTER and BRITTNEY JADE SIAS, who with the intent to defraud, falsely made, altered, forged, and/or counterfeited, as true and genuine, a transfer or assurance of money, certificate of shares of stock, goods, chattels or other property, specifically, Re-Conveyance, knowing the same to be false, altered, forged, or counterfeited.

COUNT 4

On or about August 4, 2016, in the County of Los Angeles, the crime of FORGERY NOT RELATING TO A CHECK, BOND, BANK BILL, NOTE OR MONEY ORDER, in violation of PENAL CODE SECTIONS 470(d) and 473(a), a Felony, was committed by CLEMENT IGNATIUS LANCELOT CHICHESTER and BRITTNEY JADE SIAS, who with the intent to defraud, falsely uttered, published, passed and/or attempted or offered to pass, as true and genuine, a transfer or assurance of money, certificate of shares of stock, goods, chattels or other property, specifically, Re-Conveyance, knowing the same to be false, altered, forged, or counterfeited.

Furthermore, as to count(s) 1, 2, 3 and 4 the offenses alleged are related felonies, a material element of which is fraud and embezzlement, which involved a pattern of related felony conduct, and the pattern of related felony conduct involved the taking of, and resulted in the loss by LORRAINE SECOR of, more than one hundred thousand dollars (\$100,000), thus subjecting to the additional punishment provided for in Penal Code sections 186.11(a)(3) and 12022.6(a)(1) and (2).

It is further alleged as to count(s) 1, 2, 3 and 4 that in the commission of the above offense(s) the said defendant(s), BRITTNEY JADE SIAS and CLEMENT IGNATIUS LANCELOT CHICHESTER, with the intent to do so, took, damaged, and destroyed property of a value exceeding \$200,000, within the meaning of Penal Code section 12022.6(a)(2).

On or about December 1, 2017, in the County of Los Angeles, the crime of PASSING A NON-SUFFICIENT FUNDS CHECK EXCEEDING \$950, in violation of PENAL CODE SECTION 476a(a), a Felony, was committed by CLEMENT IGNATIUS LANCELOT CHICHESTER, who willfully, with intent to defraud, made, drew, uttered and/or delivered the following check, draft or order upon a bank, depository, person, firm or corporation, for the payment of money in an amount exceeding nine hundred fifty dollars (\$950), knowing that the maker, drawer or corporation had not sufficient funds or credit for the payment of that check, draft, or order and all other checks, drafts, or orders upon funds then outstanding, in full upon its presentation:

It is further alleged as to count(s) 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27 and 28, offenses described in Penal Code section 803(c), that the above violation was not discovered until June 12, 2016 by Investigator Tamara Kessler after she received a referral to investigate a case of possible financial elder abuse and spoke to Lorraine Secor regarding the sale of the rental property and her life and annuity investments on January 6, 2017, and that no victim of said violation and no law enforcement agency chargeable with the investigation and prosecution of said violation had actual and constructive knowledge of said violation prior to said January 6, 2017, because the crimes involved fraud and deceit, within the meaning of Penal Code section 803(c).

It is further alleged as to count(s) 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27 and 28 that in the commission of the above offense(s) the said defendant(s), CLEMENT IGNATIUS LANCELOT CHICHESTER, with the intent to do so, took, damaged, and destroyed property of a value exceeding \$200,000, within the meaning of Penal Code section 12022.6(a)(2).

**NOTICE:** A Suspected Child Abuse Report (SCAR) may have been generated within the meaning of Penal Code §§ 11166 and 11168 involving the charges alleged in this complaint. Dissemination of a SCAR is limited by Penal Code §§ 11167 and 11167.5 and a court order is required for full disclosure of the contents of a SCAR.

**NOTICE:** Any allegation making a defendant ineligible to serve a state prison sentence in the county jail shall not be subject to dismissal pursuant to Penal Code § 1385.

**NOTICE:** Conviction of this offense prohibits you from owning, purchasing, receiving, possessing, or having under your custody and control any firearms, and effective January 1, 2018, will require you to complete a Prohibited Persons Relinquishment Form (“PPR”) pursuant to Penal Code § 29810.
