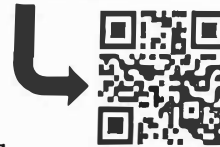

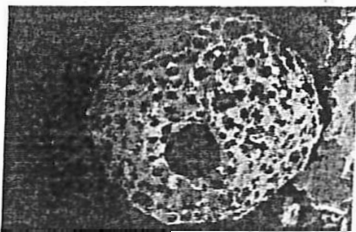


Fig. 1: 10,000x SEM Image of a char spheroid.

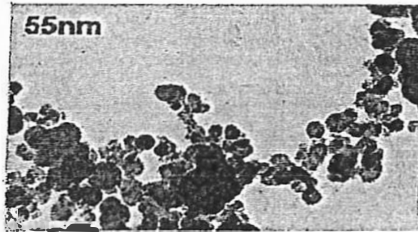


Fig. 2: 100,000x magnification of black carbon (soot).

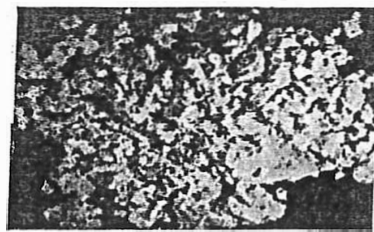


Fig. 3: RLM Image of ash.
