- and industry engagement through leadership on diversity and innovation that protects consumers throughout our California's insurance industry.
- The IDTF is committed to spearheading policies and programs that promote supplier and board diversity within California's insurance industry.
- The purpose of committee meetings is to make sure we execute our strategic plan.
- Our strategic plan is predicated on four pillars: 1) communications and public relations, 2) community engagement, 3) access to opportunities, and 4) recognition and accountability.

b) Supplier Diversity - Strategic Goals & Objectives

- Chandara Phanachone highlighted the value of showcasing industry case studies and success stories from companies actively leading in supplier diversity practices. She emphasized that sharing these examples helps demystify the process for other businesses and inspires action.
 - Mark Marales recommended continued collaboration with certifying bodies and chambers of commerce to raise awareness and engage their members.
 - Imelda Alejandrino suggested prioritizing outreach to women-owned small insurance companies and connecting with organizations like the Women's Business Enterprise National Council (WBENC).
 - Committee members noted that the Small Business Diversity Network (May 14), SCMSDC B3 Event (May 15), and the NGLCC Conference in Las Vegas are key opportunities for visibility and engagement.
- It was suggested that we engage members of chambers of commerce and other diversity organizations.
 - Many organizations have upcoming events in the spring and summer— Small Business Diversity Network, National Minority Supplier Development Council, NBLCC, and WBENC
- OIDI is finalizing a communications and outreach toolkit
 - The toolkit will include a standardized presentation deck and Diversity Factsheets for use by Task Force members and partners.
 - The new Diversity Factsheets are designed to support outreach and education on demographic diversity in the insurance industry. Factsheets debuted at the 2025 California Supplier Diversity Symposium in March and received highly positive feedback.
 - Factsheets will be sent to Task Force, as well as made available on the OIDI website.
